

MCM Comic Con London May 2020 HotelMap Hotel Room Free Prize Draw

Terms and Conditions

1. Who are we?

- The **MCM Comic Con London May 2020 HotelMap Hotel Room Free Prize Draw** (referred to in these terms and conditions “**the Prize Draw**”) is offered to you by **MCM Expo Limited**, whose principal place of business is at 1-6 Grand Parade, Brighton, East Sussex BN2 9QB and whose registered office is at Gateway House, 28 The Quadrant, Richmond, Surrey TW9 1DN (hereinafter, also known as “**we**” or “**us**”).
- We are the organiser of the **MCM Comic Con** events, including the MCM Comic Con London May 2020 event taking place at the ExCel Centre, London, on Friday 29th May, Saturday 30th May and Sunday 31st May 2020 (“**the Event**”), and the owner and controller of the website www.mcmcomiccon.com (referred to in these Terms and Conditions as “**the Website**”).
- The Prize Draw is for accommodation (room only) for two people for up to three (3) nights, from Friday 29th to Sunday 31st May 2020 inclusive, at the Aloft London ExCel Hotel, Royal Victoria Dock, One Eastern Gateway, London E16 1FR. We have five (5) individual Prizes to give away.

2. What terms, conditions and rules apply to the Competition?

- These Terms and Conditions apply to the Prize Draw. You will be deemed to have accepted these Terms and Conditions and to have agreed to be bound by them upon entering the Prize Draw, which you will enter by virtue of having acquired, for valuable consideration, a **weekend ticket** for the Event. If you are in breach of these Terms and Conditions, you may be excluded from access to the Prize Draw.
- You must be over 18 years of age at the date of entry in order to participate in the Prize Draw.

- Entry into the Prize Draw is only through the successful purchase of a **full-price weekend ticket** for the Event **prior to midnight UK time on Saturday 15th February 2020**.
- Unfortunately, the following persons are excluded from entering the Prize Draw and their entries will not be considered:
 - (a) employees of MCM Expo Limited or Reed Exhibitions Limited and any associated company of Reed Exhibitions Limited;
 - (b) employees of the HotelMap.com Limited and any associated company of HotelMap;
 - (c) any person directly or indirectly involved in the running of the Prize Draw;
- All qualifying entrants who purchase a full weekend ticket to the Event prior to midnight on Saturday 15th February 2020 will be entered into the Prize Draw to win accommodation (room only) for two people for up to three (3) nights, from Friday 29th to Sunday 31st May 2020 inclusive, at the Aloft London ExCel Hotel, Royal Victoria Dock, One Eastern Gateway, London E16 1FR.

Prize Draw Guidelines

- The Prize Draw will run until midnight UK time on Saturday 15th February 2020 (“**the Closing Date**”). Any entries received after the Closing Date will not be accepted.
- We may, at our discretion, alter, amend, suspend or withdraw the Prize Draw without prior notice. We will not change the Closing Date unless forced to do so by unavoidable circumstances outside of our control. Any such changes will be indicated on the Website and it is your responsibility to check for any changes.

Prize Details

- Each Prize is for one of five standard hotel rooms for up to two people – for three (3) nights, from Friday 29th to Sunday 31st May 2020 inclusive, at the Aloft London ExCel Hotel, Royal Victoria Dock, One Eastern Gateway, London E16 1FR.
- The Prize must be used only on the dates above.
- The Prize cannot be exchanged for cash or any other equivalent.

3. How much will it cost me to enter the Prize Draw?

Entry is free of charge, with each and every purchase of a weekend ticket to the Event. If you are a Winner, you will be responsible for any travel and other related costs to get to the hotel as well as for any food or drink and other incidentals associated with the room.

4. **Selection of Winner**

- On Wednesday 19th February 2020, five entrants will be drawn at random from the Prize Draw entries received from all qualifying entrants and each such entrant will become a winner in accordance with these Terms and Conditions (“a **Winner**”),
- If you are a Winner, we reserve the right to verify your eligibility and to check or validate your identity. If you have been asked for proof of your identity and/or your eligibility, including your age, your failure to provide such proof within a reasonable time could result in your disqualification from the Prize Draw and a fresh Winner will be selected. All personal details and information you supply must be truthful and accurate.
- Each Winner will be notified **before 17:00 hours UK time on Thursday 20th February 2020** via their email address or other contact details supplied when they purchased their weekend ticket for the Event.
- In order to redeem the Prize, each Winner will be required to send their acceptance to us via email **on or before 17:00 hours UK time on Friday 21st February 2020**. Each Winner, on acceptance, must notify us of their email address so details of the Prize can be despatched and HotelMap.com Limited put in touch with each Winner to enable the Prize to be confirmed. The Winner’s failure to provide acceptance by the time/date stipulated above could result in disqualification from the Prize Draw and a fresh Winner being selected at random.
- Subject to us receiving the required acceptance above, the Prize will be sent to each Winner via email within three (3) working days of when such Winner has confirmed acceptance.
- If you are a Winner and you have already pre-booked other accommodation in London or elsewhere for the Event, it is your responsibility to cancel such accommodation or pass it on to a third party or otherwise negotiate with the hotel or their agency.
- If you are a Winner, we or HotelMap.com Limited may ask your permission to take your photograph or we may ask you to provide a photograph. Subject to receiving your consent, you authorise such photography and permit us or HotelMap.com Limited to use your photograph, image and likeness for our own or their own promotional purposes only in any media.
- We must either publish or make available information that indicates that a valid Prize Draw took place. To comply with this obligation, we will send the surname and county of the Winners of the Prize to anyone who emails us or writes to the address set out in paragraph 1 (enclosing a self-addressed envelope) within one month after the Closing Date of the Prize Draw. If you object to your surname and county being published or made available,

please contact us at the email address at the top of these Terms and Conditions. In such circumstances, you should note that we must still provide the information and Winners' details to the Advertising Standards Authority, on request.

5. How will we use your personal details?

We will only use your personal details to operate the Prize Draw to verify your identity and eligibility, to notify you if you are a Winner and to use your surname and county as well as, with your consent, your photograph for promotional purposes only.

We will delete all unsuccessful entrants' personal details as soon as all the Winners have accepted their Prize and we will delete each Winner's personal details as soon as the Prize has been accepted and used in full by such Winner.

6. How far are we liable or responsible to you?

Nothing in these Terms and Conditions removes or limits our liability for fraud, for death or personal injury caused by our negligence or for any liability which cannot be limited or excluded by law. These Terms and Conditions also do not affect the rights that are granted to you as a consumer by law. Otherwise, we will not be liable to you for any matter relating to the Prize Draw offered by us. We will also not be liable to you if you suffer loss or inconvenience because of the failures of persons or systems that we do not directly control – for example, mobile phone network operators, internet service providers, postal services, software providers and telephone traffic handlers.

7. The legal position of these terms and condition

These Terms and Conditions form a legally binding agreement between you and us. We reserve the right to change them and update them from time to time but, if we do so, we will post the changes on the Website. The Prize Draw is run and organised by us strictly in accordance with the laws of England and Wales. These terms and conditions shall be governed by the laws of England and Wales and the parties submit to the exclusive jurisdiction of the courts of England.
