

## Vagrant Queen Blu Ray MCM Comic Con Free Prize Draw, in conjunction with Warrior

### Terms and Conditions

#### 1. Who are we?

- The **Vagrant Queen Season One Blu Ray Free Prize Draw** (referred to in these terms and conditions “**the Prize Draw**”) is offered to you by **MCM Expo Limited**, whose principal place of business is at 1-6 Grand Parade, Brighton, East Sussex BN2 9QB and whose registered office is at Gateway House, 28 The Quadrant, Richmond, Surrey TW9 1DN (hereinafter, also known as “**we**” or “**us**”), in conjunction with The Warrior Agency (“**Warrior**”).
- We are the organiser of the **MCM Comic Con** events and the owner and controller of the website, [www.mcmcomiccon.com](http://www.mcmcomiccon.com) (referred to in these Terms and Conditions as “**the Website**”), and the MCM Comic Con Instagram social media site.
- The Prize Draw is for three (3) lots of a free copy of the Blu Ray of **Vagrant Queen – Season One** which goes on general release on 13<sup>th</sup> July 2020 (“**the Prize(s)**”) and is being run by MCM Expo Limited in conjunction with Warrior.

#### 2. What terms, conditions and rules apply to the Competition?

- These Terms and Conditions apply to the Prize Draw. You will be deemed to have accepted these Terms and Conditions and to be bound by them upon entering the Prize Draw, which Prize Draw you will enter by means of liking and retweeting the post for **Vagrant Queen – Season One** on the MCM Comic Con Twitter feed. If you are in breach of these Terms and Conditions, you may be excluded from access to the Prize Draw.
- You must be over 18 years of age at the date of entry to participate in the Prize Draw.
- Entry into the Prize Draw is via the MCM Comic Con Twitter and Facebook feed/site only.
- Unfortunately, the following persons are excluded from entering the Prize Draw and their entries will not be considered
  - (a) employees of MCM Expo Limited or Reed Exhibitions Limited and any associated company of Reed Exhibitions Limited;
  - (b) employees of Warrior and any associated company of Warrior; and

(c) any person directly or indirectly involved in the running of the Prize Draw;

- All qualifying entrants will be entered into the Prize Draw to win one of the Prize(s).

### **Prize Draw Guidelines**

- You must ensure that, upon entering the Prize Draw, your Twitter feed/account is a valid one owned by you. If the Twitter account supplied is invalid for whatever reason, we reserve the right to withdraw the entrant from the Prize Draw. Our decision in this regard is final.
- You will only be entitled to submit one entry for the Prize Draw. Any duplicate entries will be removed.
- The Prize Draw will run from 10.00 hours UK time on Monday 13<sup>th</sup> July 2020 (“**the Opening Date**”) to 10.00 hours UK time on Friday 17<sup>th</sup> July 2020 (“**the Closing Date**”). Any entries received either before the Opening Date or after the Closing Date will not be accepted.
- We may, at our discretion, alter, amend, suspend or withdraw the Prize Draw without prior notice. We will not change the Closing Date unless forced to do so by unavoidable circumstances outside of our control. Any such changes will be indicated on the Website as well as the MCM Comic Con Twitter feed and it is your responsibility to check for any changes.

### **Prize Details**

- Each one of the three (3) Prizes is a copy of the Blu Ray of ***Vagrant Queen – Season One***.
- The three (3) Prizes are the only ones available and cannot be exchanged for cash or any other equivalent.

#### **3. How much will it cost me to enter the Prize Draw?**

Entry is free of charge. No purchase is necessary.

#### **4. Selection of Winner**

- On Friday 17<sup>th</sup> July 2020, three (3) entrants will be drawn at random from the Prize Draw entries received from all qualifying entrants and each of those entrants will become a Winner in accordance with these Terms and Conditions (“**the Winner(s)**”),
- If you are a Winner, we reserve the right to verify your eligibility and to check or validate your identity. If you have been asked for proof of your identity and/or your eligibility, including your age, your failure to provide such proof within a reasonable time could result

in your disqualification from the Prize Draw and a fresh Winner selected. All personal details and information you supply must be truthful and accurate.

- Each Winner will be notified via their Twitter feed/account before 17:00 hours UK time on Monday 20<sup>th</sup> July 2020. In order to redeem the Prize, each Winner will be required to send their acceptance to us via Twitter or an email account on or before 13:00 hours UK time on Tuesday 21<sup>st</sup> July 2019. Each Winner, on acceptance, must notify us of their address so that the Prize can be sent out by Warrior directly to such Winner.
- Subject to us receiving the acceptance above, the Prize details will be sent to each Winner by Warrior within three (3) working days of when the Winner has confirmed acceptance.
- If you are a Winner, we or Warrior may ask your permission to take your photograph or we may ask you to provide a photograph. Subject to receiving your consent, you authorise such photography and permit us or Warrior to use your photograph, image and likeness for our own or their own promotional purposes in any media only.
- We must either publish or make available information that indicates that a valid prize award took place. To comply with this obligation, we will send the surname and county of each Winner of the Prize to anyone who emails us or writes to the address set out in paragraph 1 (enclosing a self-addressed envelope) within one month after the Closing Date of the Prize Draw. If you object to your surname and county being published or made available, please contact us at the email address at the top of these Terms and Conditions. In such circumstances, you should note that we must still provide the information and all Winners' details to the Advertising Standards Authority, on request.

#### **5. How will we use your personal details?**

We will only use your personal details to operate the Prize Draw to verify your identity and eligibility, to notify you if you are a Winner, to notify Warrior as to the name and addresses of the Winners (to send the Prizes) and to use each Winner's surname and county as well as, with your consent, your photograph for promotional purposes only.

We will delete all unsuccessful entrants' personal details as soon as the three Winners have accepted their Prize(s) and we will delete the Winners' personal details as soon as the Prizes have been accepted, despatched to the Winners and received by the Winners.

6. **How far are we liable or responsible to you?**

Nothing in these Terms and Conditions removes or limits our liability for fraud, for death or personal injury caused by our negligence or for any liability which cannot be limited or excluded by law. These Terms and Conditions also do not affect the rights that are granted to you as a consumer by law. Otherwise, we will not be liable to you for any matter relating to the Prize Draw offered by us. We will also not be liable to you if you suffer loss or inconvenience because of the failure of persons or systems that we do not directly control – for example, mobile phone network operators, internet service providers, postal services, software providers and telephone traffic handlers.

7. **The legal position of these terms and condition**

These Terms and Conditions form a legally binding agreement between you and us. We reserve the right to change them and update them from time to time but, if we do so, we will post the changes on the Website as well as the MCM Comic Con Twitter feed/account. The Prize Draw is run and organised by us and Warrior strictly in accordance with the laws of England and Wales. These terms and conditions shall be governed by the laws of England and Wales and the parties submit to the exclusive jurisdiction of the courts of England.
